I agree to abide by the Constitution and By-Laws, as well as the Code of Ethics of the Grand County Builders Association to which this membership application is directed, of the National Association of Home Builders (NAHB) and of the Colorado Association of Home Builders (CAHB) with which it is affiliated. **A remittance of \$535 representing my annual membership dues GCBA \$138, CAHB \$215 and NAHB \$182 accompanies this application.**

Dues payments to GCBA are not deductible as charitable contributions for federal income tax purposes. However, dues payments may be deductible as ordinary and necessary business expense, subject to exclusion for lobbying activity. Because a portion of your dues is used for lobbying by NAHB and CAHB, 16% of the total dues, or \$69.50 is not deductible for income tax purposes. *A portion of your membership dues may be transferred to a political committee or used for political purposes. If your company has explicit policy against such activities, please specify your objection and the amount that would have been expended for political purposes will be transferred to the CAHB State and Local Issues Fund.*

Members will be assessed, in accordance with the By-Laws of the CAHB, for building permits issued in their name for single family dwellings at the rate of \$25.00 for each building permit pulled. The first \$1500 of building permit assessed will stay within the Grand County Builders Association general fund. This money is used by the CAHB for lobbying and political efforts, which directly affect the building industry in Colorado. **I understand that the Colorado Association of Home Builders will transfer a portion of my dues to the Committee for the American Dream, a political committee under Colorado law.**
